**[PROPOSED] ORDER GRANTING
PUTATIVE JOHN DOE'S *EX PARTE*
APPLICATION FOR LEAVE TO TAKE
EARLY DISCOVERY AND FOR A
FURTHER STAY OF THE SUBPOENA
RETURN DATE**

1 The Court, having duly considered Putative John Doe's *Ex Parte* Application for Leave to
2 Take Early Discovery and For a Further Stay of the Subpoena Return Date, including the
3 supporting declaration and appendices thereto, rules as follows:


5 IT IS ORDERED THAT:
6

7 1. John Doe's ex parte application is GRANTED in full. John Doe may, within
8 fifteen days from the date hereof, propound the limited written discovery set forth in the
9 instant *ex parte* application. The subpoena return date for the subpoena issued by plaintiff
10 to Comcast, seeking John Doe's identity, is stayed pending further order of this Court.
11

12 2. John Doe's ex parte application is GRANTED in part and DENIED in part.
13 The request to propound early discovery is denied. However, the request for a stay of the
14 subpoena return date for an additional 30-days is granted. The subpoena return date for the
15 subpoena issued by plaintiff to Comcast, seeking John Doe's identity, is stayed until
16 Monday January 28, 2012, in order to allow the putative John Doe to file a motion to
17 quash. If the putative John Doe does file a motion to quash on or before January 28, 2012,
18 the subpoena return date is hereby stayed until this Court decides that motion.

20 IT IS FURTHER ORDERED that plaintiff shall, by the next business day after the date of
21 the entry of this order, give notice to Comcast, by appropriate means, and the notice shall
22 include a copy of this order. SO ORDERED.
